Booking is strictly personal and may under no circumstances be transferred without agreement of the Manager. On receipt of the booking coupon signed together with the required payment, and after confirmation, booking becomes final. Deposit will be deducted from the stay, except the non-refundable 14.00 € costs and optional cancellation insurance.

The balance of the stay has to be paid one month prior to your arrival. Check-in is on the day mentioned on the booking coupon. After 8:00 p.m., please contact the campsite. A 24 hour-delay is allowed. Beyond this period, and the campsite being not informed, booking will be cancelled. No refunding nor deduction will be made in case of late arrival or early departure.

Rental is from 3:00 p.m. Saturday to 10:00 a.m. the next Saturday.

In case of early departure, the whole amount is due, except in case of force majeure : death, serious illness with medical certificate...

By way of derogation in the hypothese where the cancellation of the stay would be justified by the fact that one of the participants would be affected directly or indirectly by the covid 19 (infection or contact case) and that this situation would call into question his participation in the stay ,the processing and management fees shall remain payable to the Service Provider.

The customer must imperatively justify the event giving rise to cancellation without severance.

By way of derogation in the hypothese where the Customer would be forced to cancel the entire stay due to government measures that do not allow participants to travel (local lockdown, travel ban, even though the campground is able to execute its .obligation and to welcome them. The Service Provider shall issue a credit note corresponding to the sums paid by the Client ,less the processing and management costs which will remain acquired by the service Provider.

The deposit cheques will be returned to you 15 days after departure.

The tourist tax is not included in the rates. The amount of the tourist tax and the VAT (10%) in force, can be modified at the time of invoicing, according to municipal decree and legislation. (*0,66 Euros per day/person) from 1 April to 30 September (year 2024).

Rules and regulations of the campsite shall be respected.

Rules of procedure are displayed at the entrance to the establishment and at reception. The Customer is required to read and respect it.
