Campsite rules

1) Admission requirements :

In order to be allowed onto the campsite, you will need the authorisation of the person in charge of reception.

A stay on Ile des Loisirs campsite implies acceptance of these rules. Where these have not been adhered to, those infringing them may be required to leave the campsite, under police enforcement if necessary.

2) Police formalities :

Anyone staying at least one night on the campsite must first present the necessary ID to reception and fill in any forms required by the police.

3) Installation :

The tent or the caravan and all equipment must be installed within the boundaries of the site indicated by the manager.

4) Reception Office :

Opens 9am to 12.30pm and from 2.30 pm to 7pm. You will find there all the information concerning services and supplies available on site, along with information relating to sporting installations, places of interest to visit in the area, and any useful addresses.

5) Payments:

Sums due are paid at the Reception. The amounts due is calculated according to the tariffs indicated in reception. These relate to the number of nights spent on the campsite. Campsite users are advised that they are required to inform the reception of their date of departure the day before that departure is due. Those campers intending to leave before the reception office opens are required to settle payment of all amounts due the day before departure.

6) Noise

Campsite users are requested to avoid all noise and loud conversations that may disturb their neighbours. The same applies to sound systems and radios. Please close car doors and boots as quietly as possible.

Dogs and other animals must never be allowed off the lead. They must never be left on the campsite, even shut in, when their owners are not on site. Silence must be respected starting from 10pm

7) Visitors :

All visitors to the campsite are the responsibility of the users of the campsite whom they are visiting. If the visit lasts longer than 2h then they will be liable for an individual supplementary payment.

8) Circulation and parking of the vehicles :

Speed limits within the campsite area are 10km/h. No vehicles are permitted to circulate between the hours of 10pm and 7am.

Only those vehicles belonging to campsite users are allowed to circulate within the campsite area. When parking your vehicle, please ensure that you never park on sites usually reserved for camping, and take particular care not to impede easy circulation of other vehicles and those arriving to set up tents etc.

9) Site appearance and maintenance :

Each campsite user is required to avoid all actions that could damage or affect the cleanliness, hygiene or appearance of the campsite.

Do not throw dirty water on the ground or in the gutters. Caravan owners must dispose of their dirty water in those installations provided for that purpose.

10) Security

a) Fires

Open fires (wood, coal, etc.) are strictly forbidden. Stoves must be maintained in good working order.

Fire extinguishers are available to all. In case of fire, inform the reception at once. A first aid kit is available on request at reception.

b) Theft

The management is only responsible for those objects left at their office. You must inform them immediately if there is someone acting suspiciously on site. Although best efforts are used to ensure campsite security, it is advisable that campsite users take all usual and necessary precautions to protect their property and equipment.

11) Games

No games that are violent or infringe someone else's privacy may be played in proximity to the installations. The meeting room may not be used for animated games.

12) 'Dead garage'

Equipment not in use may only be left on the campsite with the approval of the management, and only where indicated. A payment, the amount of which can be found at reception, will be due for use of the 'dead garage' facility.

13) Persons in charge of the campsite

They are responsible for the order and for the good behaviour of the camp. They are in charge of the consequences of breach of these rules, and where necessary is capable of requiring those persons in breach of the rules to leave the campsite.

Campsite users may enter any comments in a visitors book held at reception.
